TFCD (Trade for CD) model release

In consideration of my engagement as a model, upon the terms herewith stated, I hereby give to **Grant Jones / Digiography** his/her heirs, legal representatives and assigns, those for whom **Grant Jones / Digiography** is acting, and those acting with his/her authority and permission.

I hereby release, discharge and agree to hold harmless the Photographer and all Authorized Parties, individually and jointly, from any liability to me or others associated with me by virtue of any blurring, distortion or alteration of the Released Images, or use of the Released Images in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said Released Images or in any subsequent processing, publication or usage thereof, including without limitation any claims of defamation or violation of rights of privacy or publicity. I acknowledge and agree that this release and agreement to hold harmless shall continue indefinitely, regardless of whether any Released Image used within the scope of this Agreement causes me in the future to feel embarrassed, ashamed, degraded or otherwise injured in any manner. I agree to the following:

a) I understand that I will be given the opportunity for 14 days to preview proofs of all usable images and approve which images will be post-processed for final selection, after which I hereby relinquish any right that I may have to examine or approve the completed product or products or printed matter that may be used in conjunction therewith or the use to which it may be applied, in which case, final selection will be of the photographer's choosing.

b) I accept as compensation for this session high-resolution copies of final selection digital images delivered on a CD. I understand that no prints will be provided. I understand that images taken either on film or digitally are provided in this format as described.

c) I give the unrestricted right and permission to use, re-use, publish, and republish final selection photographic portraits or pictures of me or in which I may be included intact or in part, composite or alterations in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter for purposes of online self-promotion, such as website galleries, portfolios in recognized modeling online communities, and postings to legitimate photography forums.

We further release the Photographer, or others for whom he is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial or artistic use of these images unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting the Model to conspicuous ridicule, scandal, reproach, scorn and indignity.

d) I permit the use of printed material for purposes of self-promotion, such as business cards and portfolio books.

e) I am authorized to use these images for purposes of self-promotion in the same manner as the photographer.

f) Any sale of images from this session by either party will be subject to separate agreement.

Notes:

Although Grant Jones/Digiography will own the copyright on the images each party will have the right to mutual use of the images for self-promotion.

Both parties agree to be sensitive to the nature of where the images are posted and in keeping with this understanding will endeavor to avoid posting images in a way, place or manner that could prove embarrassing, degrading or insensitive to the sensibilities of either party to this agreement.

The model will not alter the final images in anyway with the exception of resizing without permission from Digiography.

Both parties agree where practical and possible to give credit to the other party involved in the creation of the image either by tagging directly on the image or in print copy associated with the image. Also where possible each party will notify the other about where the images are going to be posted before the fact.

Any significant income generated by the sale of images from this session will be mutually divided on a 50% / 50% basis.
